Said Carrier shall at all times while operating under this permit, or any amendment or supplement thereto, observe and comply with all decisions, orders, rules, and regulations issued, prescribed or adopted by this Commission relating to
- 5 This permit shall be subject to amendment or modification from time to time by this Commission as conditions may warrant or require and shall also be subject to suspension or revocation as provided in the Public Utilities Code.
- 6) This permit shall not be sold, assigned, leased, or otherwise transferred or encumbered without Commission
- 3 This permit shall lapse and terminate if not exercised for a period of one year.
- (8) Operations under this permit are limited to the State of California.
- (9) Operations under this permit are limited to the following conditions: Statewide
- (10) Regardless of any restriction in item (9) above, this permit also authorizes the above-named Carrier to transport office, store, and institution furniture and fixtures over any public highway in the State of California, if the Carrier has elected to do so in accordance with Section 5137 of the Public Utilities Code.
